



## EDITING CONTRACT

### I. Contracting parties

### II. Object of contract

Art. 1. The author hereby grants to the Journal the exclusive right to edit and to distribute the Work (article, review, essay) titled:

### III. Royalty payment

Art. 2. The Journal will not pay any royalties to the Author in exchange of editing rights.

### IV. Obligations of the parties

Art. 3. The Author hereby warrants to the Editor that:

- She/he has the right and the full power to enter this contract;
- The Work is not subject to other editing contracts and is an original work by the Author;
- The quotes and/or other materials (text, illustrations, etc.) inserted into the Work (with the exception of those that belong to the public domain) are used with the permission of their copyright holder, and that publishing the Work will not infringe upon any copyrights and/or other heretofore concluded contracts;

– All the statements and data included in the Work are correct and comply with scientific, historical, etc. truth;

Art. 4. The Author agrees to submit the Work (with its illustrations, figures, etc.) in its final form on or before \_\_\_\_\_ in electronic format. Once submitted to the editorial team the Work shall not bear any other alteration. The Author shall not introduce new text, images, appendices (a different bibliography, a new index, etc.) into the Work unless she/he is granted the written permission of the Journal's board. Graphics, copy-editing and proofreading, typesetting and layout belong exclusively to the Journal. The Author may be consulted upon her/his request; the final decision belongs exclusively to the editorial team.

Art. 5. The Author(s) warrants not to grant the right to edit and to distribute the Work subject to this contract to any other publication or legal/natural person without the written consent of the *Polis* Journal board, complying with the copyright term of at least 3 months from the publication of the Work in its online version.

Art 6. The Author(s) warrants not to authorize the translation or the partial publication of the Work without the written consent of the *Polis* Journal board, complying with the copyright term of at least 3 months from the publication of the Work in its online version.

Art. 7. Should the Work be republished under the circumstances described in Art. 5 and 6 of this contract, the Author has the obligation to mention that it was first published in the *Polis* Journal, giving full bibliographical references (journal issue and pages).
